## TERMS & CONDITIONS OF ENTRY

The promoter is THE LION Richlands Pty Ltd. By participating in Trivia, you are agreeing to the following terms and conditions. Participant details remain the property of THE LION Richlands Pty Ltd.

At the beginning of trade on Trivia days (Tuesdays), a sign is to be placed on each table notifying patrons that the tables will no longer be available from 5pm as they are reserved for Trivia.

The room is to be set up with specified tables prior to 5.30pm... room layout provided, and to be updated regularly. The Trivia folder is to be provided to the Sports Bar staff prior to 5.30pm containing winning vouchers and cash, run sheet, booking sheet, USB with the music for the Trivia host etc.

The Trivia host will arrive at approx. 6.45pm, for a start time of 7pm. The Trivia host is to make the announcement as part of housekeeping that bookings are essential and the booking form is at the bar, and will be taken to reception after Trivia. If participants phone the club in order to make a booking and are answered by one of our phone roll team members, they are to be transferred back to reception to update the booking form.

Signs are to be placed at the entrances of the Sports Bar once the room has reached a capacity of 100 people.

Any Trivia participants who show any form of aggression towards a staff member will be asked to leave the premises. Participants who bring alcohol onto the premises will also be asked to leave.

The breakdown of the Trivia prizes is as below -

Trivia's prizes are as follows: 1<sup>st</sup> prize \$100 cash, 2<sup>nd</sup> prize \$60 cash, 3<sup>rd</sup> prize \$20 club voucher, second last prize \$10 club voucher and 3x \$10 club vouchers as sport prizes (Given away at hosts discretion).

Trivia's jackpot begins and resets back to \$100. Each week if the jackpot goes by unclaimed, \$100 gets added onto for the next week.

THE LION Richlands is not liable for any loss, damage or injury by any person in connection with the Promotion.

Trivia is subject to change, pending COVID closures or further restrictions are announced. The Lion Richlands reserves the right to cancel Trivia should restrictions or staffing issues arise. These changes will be announced via social media.

The decisions of the management of THE LION Richlands are final. No correspondence or third-party actions will be entered into. If a member is found to be taking advantage of the rules or terms of Trivia, they will be excluded from all future Trivia sessions.
