

**“JACK DANIEL’S ELECTRIC FENDER GUITAR PACK” PROMOTION
– QLD ONLY**

TERMS AND CONDITIONS

1. Information on how to enter and the prize form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. Entry is only open to Queensland residents aged 18 years or over who are club members of this participating venue.
3. Employees (and their immediate families) of the Promoter, participating venues and agencies associated with this promotion are ineligible to enter.
