### **TERMS & CONDITIONS OF ENTRY**

Members drawn are to select a claw that the gaming host is wearing to see if they're picked a red ball or black ball. Red ball is worth \$75 & Black ball is worth \$100.

If the claw reveals a red ball, they win \$75 cash & can choose to gamble this & double their money. If the member picks the red ball again, they win \$150. If the member picks the black ball on their gamble, they win a consolation prize of \$50.

If the claw reveals a black ball, they win \$100 cash & can choose to gamble this & double their money. If the member picks the black ball again, they win \$200. If the member picks the red ball on their gamble, they win a consolation prize of \$50.
